List of countries exempt from visa to Vietnam

As of August 2022, Vietnam is exempting visas for citizens of 25 countries (ordinary passports), including:

Vietnam offers bilateral visa exemption for citizens of 12 countries, and

Vietnam offers bilateral visa exemption for citizens of 13 countries, including 11 European countries (instead of the previous 5 countries).

The maximum allowed stay period and visa exemption conditions for each country are specified in the table below.

Important notes about Vietnam visa exemption cases:

- Regulations on Foreigners subject to unilateral visa exemption, if the next time they enter
 Vietnam and want to use visa exemption, they must wait at least 30 days from the date of
 departure of their first stay in Vietnam. The nearest Vietnamese visa exemption status
 will be removed from July 1, 2020. Thus, citizens of countries under Vietnam visa
 exemption are always exempted from visa for up to 15 days.
- People with British citizen passports abroad BNO are not eligible for Vietnam visa exemption.
- Visa exemption includes visa exemption for entry, exit and transit.
- Visa-free temporary stay period is calculated from the date of entry.

The visa exemption table for entering Vietnam above (updated March 10, 2022) is for information only. Maybe some new information has not been specifically updated. Other Vietnam visa exemption cases

Currently, in addition to the visa exemption cases mentioned above, Vietnam is also exempting visas for the following cases:

1/30-day visa exemption for foreigners entering coastal economic zones according to the Government's decision when meeting all the following conditions:

- has an international airport;
- have separate space;
- has a defined geographical boundary, separate from the mainland;
- consistent with socio-economic development policies and does not harm Vietnam's national defense, security, social order and safety.

2/ APEC Business Travel Card (ABTC) holders with valid passports are exempt from visa entry and stay in Vietnam for up to 60 days;
